Executive Director's Report January 13, 2022

Preface

Happy New Year!

When I interviewed here three years ago I said that I am not as much into events as I am ongoing ministry to the churches we serve. True to that statement, the greatest portion of network effort since the annual meeting has been day-to-day support of our core ministry strategies, the PLAN. We've not ignored events. Preparation for events central to the PLAN are well underway. And our strategy team has met regularly, completing the first phase of three leading to a fresh expression of our network commitments. But the heart of what we do is serving churches and those who serve through them. Here's what that's looked like since October.

Planting

GTBN continues coaching and funding church plants, Providence Baptist Church Beaumont and Brighter Day Ministries. And, as soon as BGCT completes their process, we will join North Orange and North End in supporting River City Church in Vancouver, Washington, where we hope to send a team this spring. Beside these, I continue working with Central City Beaumont to replant. With Community Harvest as primary partner, we have partnered with Bro. Fidel Irizarry, who has gathered a group of about twenty, to join Central City as replanting pastor. We budgeted to fund them at \$400/ month for up to three years, assuming certain benchmarks are met. Fidel, who is covocational, says his group currently gives the same.

Action: I need a team of volunteers to join me to deep clean Central City so the new group can launch. Need a date (soon) and a commitment. GTBN will arrange the dumpster. Also planning prayer walk day.

One more Planting Note. Meetings with my counterparts in Houston concerning Hispanic church planting are bearing fruit. They informed me last week of an experienced planter who expects to relocate to Beaumont with a team. I will know more about this later, but please pray.

Leadership

Support and encouragement for church staff has been a heavy responsibility since October. I can't go into details, but no less than three key GTBN churches are experiencing significant conflict, with many more simply exhausted. As I said in a recent blog entry, pastors are facing a perfect storm of stressors. So, the pastor to pastors work goes on.

Two additional points on Leadership: (1) We have our first application pending for the Pastor Sabbatical support and (2) BGCT Bivocational Specialist Ira Antione seeks to partner with us on a Bivocational Ministers Retreat, tentatively set for Apr. 8-9. He is asking us to co-sponsor the event so that pastors and wives can attend regardless of convention affiliation.

Question: Is the board open to sharing the cost of a bivocational ministers and wives retreat, Apr. 8-9 with BGCT? Expected cost to GTBN, \$3000.

Awakening

Awakening efforts include all we do for church health and revitalization. Given the importance of disciple making to revitalization, our foundation event is DMU, conducted this year in partnership with Beaumont's First Baptist. Speakers are set and registration is open. The focus this year is Disciples Making Disciples. We expect from this to launch some pastor cohorts for modeling and implementing biblical disciple making in the church.

After the New Year I was invited by South Park to work with their new pastor on a revitalization plan. Like Central City, South Park is down to a hand-full of people. They will need some partners to turn the corner. Cove Baptist in Orange, Rosedale in Beaumont, and Meeker have also reached out for consultations.

Given the number of struggling congregations across GTBN, I have asked four men to join me for the NAMB Association Replant Lab in Atlanta, March 13-16. NAMB will pay for lodging and meals for up to 5 from the first associations to sign up. The training will equip our Church Renewal Team to lead churches to assess their options and design the best path for revitalization or replanting. This will include updated material on the different ways partners have assisted these efforts. In time we expect to present several opportunities for churches, ranging from equipping and coaching, church fostering (temporary partnerships), church adoptions, and full replants.

Action: I am asking that the Board approve spending \$2174.80 from budget line item 5140 Church Revitalization to cover conference registration and airfare.

Networking

Networking includes our collaborative mission work, locally and beyond. Locally we continue to promote collaborative events, including Hot Hearts, Night to Shine, the Unapologetic Conference, and Beast Feast.

With the Hot Hearts team working to re-establish the event "in-person" while operating on a conservative budget, I suggested GTBN might fund the regular breakfast for the Hot Hearts team

Friday morning as they prep the event. For me this provides an opportunity to connect new youth ministers (as my guests) with the team for future partnership with them.

Action: Consider funding Hot Hearts for the Friday breakfast, catered through Ford Park.

While I am addressing youth ministry, GTBN Youth Camp / Purpose Week team is hard at work preparing the 2022 camp. Nate Jordan will serve as camp pastor, with Spring Creek Church from Big Spring again leading worship. Given the facility costs at ETBE, it takes at least 200 paid campers to have camp "in the black". Since we're still rebuilding the camp program and many have concerns with ETBE facilities, we expect only 130-160 campers.

Question: Is the board open to transferring funds from surplus budget for the GTBN Youth Camp beyond the \$2000 that is in the budget?

Internationally, we continue working with Cross Media (Youseff Dakwar) and Southern Baptists of Belize (Blaine McFarlin). A report from Youseff is in your packet. Concerning Belize, I am awaiting word from Blain as to when we can resume mission trips. With the completion of church buildings for most of our Belizean partners, I would still like us to consider extending our partnership to include the Global Leader Development (GLD) initiative of Southwestern Seminary. Along this line we have a request from the president of the Baptist Seminary in Guatemala for partnering through GLD. We can discuss this at a future meeting.

Administration

Administratively all is well. At least I've received no complaints. As you've seen with the financial statement, we finished the year in a strong position.

Returning board members will remember that last year we accepted the North American Mission Board's invitation to work with Will Mancini and the Denominee network planning process. During the meeting I will share with you and update of what we've learned so far. I don't see us departing from the priorities of the PLAN but I do see the Denominee process helping us to sharpen how we pursue these priorities. When you hear the report I hope you will be as encouraged it as I am.

Conclusion

Golden Triangle Baptist Network Executive Board Minutes October 6, 2021

Rusty called the meeting to order and noted the minutes from the May meeting, which were approved without opposition. Jeff Sandusky presented the financial report, noting no irregularities. The report was approved with no opposition.

Bro. Jim presented his director's report, an early draft of his report for the annual meeting.

Among Old Business the Board considered the transfer of the former First Baptist Cheek property to Iglesia Hispania Emmanuel with a reversion clause that, should the church close or break their relationship with GTBN or the SBC, the property would revert to the ownership of GTBN. After discussion, the Board decided that we could not require the church to carry property insurance, but we would strongly encourage it. Bro. Alfredo noted that the pastor indicated his intent to keep the property insured. Jason Martin moved that we transfer the property with the reversion clause; Eric House seconded the motion. The motion carried.

Bro. Jim noted the postponement due to COVID 19 of the scheduled Bill Glass event for corrections personnel until the spring, and the ongoing discussion with Southwestern Seminary regarding the Global Leadership Development initiative. He then updated the Board on plans to take a team to the NAMB Association Replant Lab in March.

Bro. Jim updated the board on the replant process with Central City. Central City is currently not meeting, as they are financially insolvent. Mack Bronson has recommended a bilingual pastor whom Bro. Jim has met. They are working on a plan to merge his work with Central City. We may also work with Calvary and other churches to use this site as a ministry center, given its proximity to Fletcher Elementary School. As this plan comes together, the next step would be scheduling a workday to clean up Central City, prayer walk the community and prepare for the launch.

He then informed the Board that an offer is pending for the old GTBN building at 555 N. 10th Street, Beaumont, for \$124,500. He accepted and expects closing to be by or soon after the annual meeting.

For new business the board finalized the slate of nominees for the Executive Board and East Texas Baptist Encampment, the proposed 2022 GTBN budget, and the agenda for the Annual Meeting. In discussing the agenda, the Board agreed to a gift of \$5000, drawn from the annual surplus restricted account, for David Cross on his retirement as Chaplain for Baptist Hospital of Beaumont, after 40 years' service. Jeff Sandusky made the motion; Jason martin seconded. The motion carried.

Jim concluded the meeting with an update on the Denominee strategy process that he, Eric, Klem and Rusty are working through. The next meeting is scheduled for January 14, 2022 at 10:00 AM, at the GTBN office and ZOOM.
